In order to be considered as a foster family, you must:

- **BE 18 YEARS OF AGE OR OLDER.**
- Have identification showing your present address.

- Have the knowledge and consent to foster of all adults living in your household.
- Have the knowledge and consent of your landlord or the person owning the premises in which the animal will live.
- Understand that God's Feral Felines has full authority to approve or deny your Foster application.
- Understand that God's Feral Felines reserves the right to verify all information submitted on this application, including veterinary information.
- Understand that fostered cats / kittens are not allowed outdoors at any time.
- Understand that I must spend as much time as possible socializing and playing with the foster animal(s).
- Understand that I am responsible for bringing the foster animal(s) to the vet for vaccinations / spay / neuter and work with God's Feral Felines to determine where the foster animal should be brought for medical treatment.
- Understand that I must closely monitor the condition of the fostered animal(s) and contact God's Feral Felines immediately when problems are observed or when I have questions/concerns.
- UNDERSTAND THAT I MAY NOT TRANSFER OWNERSHIP OF ANY ANIMAL FOSTERED FROM GOD'S FERAL FELINES TO ANOTHER PARTY
- Understand that my services are provided strictly as a volunteer basis without any pay or compensation of any kind and without liability of any nature on behalf of God's Feral Felines; all services to be performed are at your own risk.
- Understand that in handling animals there exists a risk of injury, infection, and disease including physical harm caused by animals to my family, my pets or me. On behalf of myself, my heirs, personal representatives and executors, I hereby release, discharge, indemnify, and hold harmless God's Feral Felines, its agents, servants and board from any and all claims, causes of actions, or demands and any nature of cause, including costs and attorney fees incurred or sustained by me in any way connected with my services to God's Feral Felines but not limited to: animal bites, accidents, injuries, property damage and veterinary fees.
- I understand that the foster animal(s) are temporarily in my care and that I do not have any right of ownership over my foster animal(s).
- I understand that GFF provides no guarantee as to the health of my foster animal(s) and that he/she may have medical needs
- I agree to provide my foster animal with veterinary care as authorized by GFF. I will not arrange or pay for any elective veterinary care for my foster animal(s) without the express consent of an authorized GFF representative.
- I agree to return any foster animals in my care to GFF at the request of its authorized representative at any time and for any reason. If GFF is forced to undertake legal action to enforce this provision of the agreement, I agree to indemnify GFF for all court costs and attorneys' fees connected to such action.
- If I plan to move at any time during the period I am housing a foster kitten, I agree to contact GFF prior to my move and provide GFF with my new contact information.

- If at any point I can no longer, or do not want to continue to, provide care and shelter for my foster kittens I agree to contact GFF and arrange for surrender and return of my foster animals and any supplies provided by GFF.
- I understand that anyone interested in adopting my foster kittens (including myself) must go through the standard adoption process, and approval of candidates and placement kittens is up to GFF. (Of course we welcome your referrals)
- I understand that I receive foster animals at my own risk and can reject or return any animals for which GFF has asked me to provide care. I indemnify and hold GFF free and harmless from all liability arising out of any and all claims, demands, losses, damages, action, judgment of every kind and description which may occur to or be suffered by me, members of my household, or any third parties by reason of activities arising out of this agreement.

I AGREE THAT IF I REFUSE OR FAIL TO COMPLY WITH ANY PROVISION OF THIS AGREEMENT GFF HAS THE RIGHT TO TERMINATE THIS AGREEMENT AND HAS THE RIGHT TO IMMEDIATE SURRENDER AND RETURN OF MY FOSTER KITTENS AND ANY SUPPLIES PROVIDED. I FURTHER CONSENT TO PROVIDE GFF ACCESS TO MY PREMISES IF NECESSARY TO FACILITATE THE RETURN. I HAVE READ THIS APPLICATION IN ITS ENTIRETY, AND I AGREE THAT ALL STATEMENTS AND AGREEMENTS CONTAINED IN THIS DOCUMENT ARE MADE BY ME AND ARE TRUTHFUL, UNDER PENALTY OF PERJURY UNDER THE LAWS OF THE STATE OF ALABAMA.
